From **Dorianne Allman**: On March 31, *Taika* earned a 3<sup>rd</sup> place in her Intermediate Exterior search under Judge Sean McMurray at United States Canine Scent Sports' trial. In earning this leg she wrapped up both her element and level titles. She also qualified in Double Dog Dare under Judge Sally Underwood-Miller. Hale Reservation (Westwood, MA) was the trial site. At the March 9 USCSS's trial under Judge Rose Diece, *Taika* got 4<sup>th</sup> pace in Intermediate Exterior and Q'd in Advanced Container. She also earned 1<sup>st</sup> place in Advanced Vehicle and earned her Vehicle element title. The trial was held at Tova Training (Raymond, NH). The best we could do at our March 17 NW2 trial in Dingsman Ferry, PA was a 3<sup>rd</sup> place in our Exterior search. The trial was held at Pocono Environmental Education Center, an education partner of the National Park Service.


