Eligibility of Dogs to Enter FDC Test – Dogs who are at least 1 year of age are eligible to take the ATT as long as they are registered or enrolled with AKC and have an AKC, PAL or AKC Canine Partner number.

Disabilities – Dogs with disabilities may participate. However, if a dog has multiple disabilities (e.g., blind & deaf) such that it is unable to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title. Accommodations can be made for handlers with disabilities. **Please note special needs on your entry form.**

Bitches in Season - may be tested as the last dog(s) at the end of the day.

Directions – Interstate 91 to exit 35, North on Route 5 (0.2 miles), Right on Route 116 South (0.3 miles), Right on Pine St (0.1 miles), Left on Long Plain Rd., #353 is on the right (0.45 miles)

Food – May not be available at the test site. We will update this before the test date.

I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
