Entries close: Wednesday, April 16, 2025, at 5:00 PM. After this time, entries cannot be accepted, canceled, or substituted. *Space permitting, Day of Entries accepted*

Entries limited to 25 runs per judge per day. Entries will be first received, until the limit is reached.

Two test opportunities: Test 1 will begin at 9:00 am. Test 2 will start 30 minutes after conclusion of Test 1. You may enter both tests or select either test if entering only one. ***Two qualifying tests earns an ATT title.***

Closing Date: 5:00 PM April 16 , 2025 at the test secretary’s home after which time entries will not be accepted, canceled, altered or substituted. No entries will be accepted by phone, email, fax, or hand delivery. Express mail entries must include the signature waiver allowing them to be left at the secretary’s address. Inquiries may be directed to TRIAL SECRETARY Judith Suarez at handart@sover.net. No entry shall be made, and no entry shall be accepted, which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Secretary will add a \$25.00 collection fee to the amount of each returned check.

Pre-Entry Fee: \$25 per test in US funds to “PVKC”

Day of Entry Allowed (if space available) – Fee: \$35 per test in US funds to “PVKC”

Prizes: PVKC will award a rosette to each qualifying dog in each test.

We will open for “Day of entries” at 9:00 AM

Eligibility of Dogs to Enter ATT Test – Dogs who are at least 1 year of age are eligible to take the ATT as long as they are registered or enrolled with AKC and have an AKC, PAL or AKC Canine Partner number.

Disabilities – Dogs with disabilities may participate. However, if a dog has multiple disabilities (e.g., blind & deaf) such that it is unable to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title. Accommodations can be made for handlers with disabilities. **Please note special needs on your entry form.**

Bitches in Season - may be tested as the last dog(s) at the end of the day.

Directions – **Exit 43 Route 91** - for MA-2/MA 2-A. At traffic circle follow to MA 2A East; At the second light (Dunkin Donuts) turn right on River St. Follow to Wisdom Way. Turn right on Wisdom Way and follow to fairgrounds. Note: Laurel St will come up before Wisdom Way, also on right.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
